READ CONDITIONS CAREFULLY

- 5 This licence does not confer any right of entry to ACT unleased or leased lands of any kind. Prior to undertaking collections, a project approval form is to be submitted to the manager of any unleased land, public land or reserve in respect of each task or series of collections proposed for a defined period of time.
- 6 Animals used for scientific or educational purposes are subject to the ethics committee requirements of the appropriate authority (e.g. ANU, ACT Schools Authority, etc).
- 7 The licence holder must maintain written records containing details of date, place and numbers of fish trapped and released.
- 8 All threatened fish species captured are to be measured (caudal fork length) and data is to be provided to the Conservation Planning and Research Unit, Parks and Conservation prior to renewal or at the conclusion of the licence period.
- 9 This licence is to cover the licence holder Mr Jason Julius. All fauna will be handled only by a qualified ecologist. The Supervising Officer for this project is Peter Sheehan (M2G Environmental Manager).
- 10 You are required to keep records of the date of capture and release of each animal, including non-target animals, details of location and species. These records must be made at the time of the capture and release of each animal. Details are to be provided to the area manager at the end of each trapping run.
- 11 The activity can be carried out on approved sites only. Grid references of trap locations to be supplied to Area Manager, prior to commencement of activity.
- 12 Any vehicles entering the area are to be clean and free of any seeds.
- 13 Failure to comply with these conditions may result in cancellation of your licence and/or jeopardise future applications made under the Nature Conservation Act 1980.
