Location: Tuggeranong blocks 119, 1675, 1654 and 1572. Located between Angle Crossing and Googong Dam (part of the Murrumbidgee to Googong Dam pipeline project).

This Licence is issued in accordance with the following conditions:

- 1 This licence is not transferable.
2 The animal(s) shall not be sold, traded or otherwise disposed of (including giving and donating) without the consent in writing of the Conservator of Flora and Fauna.
3 Sick, diseased, or injured animals must receive appropriate treatment. Where necessary a qualified veterinary surgeon is to attend to the animal.
4 When fit for release the animal shall be released near the site where found, in an appropriate habitat, at an appropriate time and/or season.
5 Animals may be trapped only in a manner which does not result in injury to the animal.
6 This licence and any records required to be kept must be available for inspection by the Conservator of Flora and Fauna or any Conservation Officer.
7 This licence is to cover associated workers working under the licence holders direction during the project period for the purposes of the project as authorised above.

READ CONDITIONS CAREFULLY

- 8 If during the Murrumbidgee to Cotter Dam pipeline Project and related land works, any Special Protection Status or Protected Native Animal Species (pursuant to the Nature Conservation Act 1980) are located, the Conservator shall be notified as soon as possible, and in any case within 48 hours so that the specimen may be transferred to the care of Land Management and Planning Division..
- 9 Approval is given to hold an animal for the purposes of Condition 8 above, otherwise this licence does not authorise the keeping of live animals.
- 10 The authority contained within this licence is only valid in connection with the construction works associated with the Murrumbidgee to Googong Dam pipeline Project and may not be used for any other purpose without the written consent of the Conservator of Flora and Fauna.
- 11 This licence is issued in conjunction with licences LT2010433, LR2010172, LF20108 and LK2010270.
