

Materiality Matrix


Summary of Observations

Icon Water undertook a materiality issues assessment in line with the standard methodology for materiality to help guide our response to sustainability. We engaged with customers and stakeholders together with our business and focused on prioritising key material sustainability issues.

Materiality process

To help us in this process, we invited participants from inside and outside of the business to rate each sustainability issue based on the relative importance to the business or the stakeholder. The issues were chosen from other business materiality issues, the GRI and Dow Jones Indices, and internal consultation. The process will assist Icon Water in its pursuit to be a sustainable business.


