(Part) Monaro Highway and Monaro Highway Road Reservation - Water Infrastructure Works Associated with the Murrumbidgee River to Googong Dam Water Transfer Project

I refer to the works approval application drawings and supporting information on the above works submitted to the National Capital Authority (NCA) for consideration on 3 June 2010. I also refer to further information received on 18 June, 22 July and 1 November 2010.

The NCA advises that:

Works Approval is granted pursuant to Section 12(1)(b) of the Australian Capital Territory (Planning and Land Management) Act 1988 for the water infrastructure works to Monaro Highway and Monaro Highway Road Reservation associated with the Murrumbidgee River to Googong Dam Water Transfer Project as shown on Drawing Nos. The term "works" is defined in the Act to exclude anything done inside buildings or structures. Under the Act works approval may be given where the works are in accordance with the National Capital Plan. This works approval is given only on the basis of satisfaction that the works are in accordance with the National Capital Plan and does not constitute building approval. It does not constitute any form of warranty as to the structural sufficiency of the proposed works, as to safety of the works or as to safety of the performance of the works. It is the responsibility of the applicant to ensure the safety of the works and the safety of the performance of the works and to ensure that any approvals required under separate legislation are also obtained.

A separate application for works approval will be required to be submitted for the associated temporary traffic management works to Monaro Highway. (Note: final temporary traffic management plans are to be endorsed by Roads ACT before they are formally submitted to the NCA for works approval).
